Trustees Declare Election for Vacant Seat

The Trustees of the New Castle Common have declared a vacancy on their 13-member board, due to the passing of Richard M. Appleby, Jr. The Board has scheduled an election for Saturday, October 19, 2013.

By Charter the Trust keeps its own voter list, and residents of New Castle must be registered in order to run for or vote in a Trustee election. Voters must be at least 18 years of age on or before the date of the election, and have resided in New Castle for at least one year.

To file as a candidate for the Board, one must be at least 25 years of age on or before the date of the election, a voter registered on the Trustee list, and a resident of New Castle for at least two years. The term of office is twelve years, and the filing fee is \$100 (non-refundable).

Do you know the Due Date of your Water/Electric Bill?

Municipal Services Commission customers have often asked, "What is the due date for the water and electric bills". The bill currently reads "BILL DUE UPON PRESENTATION" but that seems to cause confusion.



In an effort to improve communication with our customers, the MSC will be changing the billing date and including a

changing the billing date and including a due date on the water and electric bills. The meters will continue to be read on (or around) the 12^{th} of the month, but we will print the bills on the 19^{th} of the month and put a due date of the 1st of the month.

DO NOT feed wild animals or Feral Cats.

Stray Cats vs. Feral Cats

What is a "Feral Cat?"

Both stray and feral cats live outdoors, where they can find food and shelter. The difference is that stray cats are usually lost or abandoned house pets - cats who are friendly with humans and can often be re-adopted. In contrast, feral cats are domestic cats that are not socialized to human contact. They live in all kinds of settings, usually in family groups called colonies.

Feral cats are generally quite good at fending for themselves, and are often able to find their own food and shelter. They are quite comfortable outdoors, and have no desire to be a house pet. Because they have not been socialized to human contact, feral cats are not adoptable. They don't belong in shelters!

Instead of animal control, there are other ways to address feral cat populations. The most humane, and proven effective, is to sterilize outdoor cats. Spay/neuter programs exist for both house cats and feral cat populations. Trap-Neuter-Return (TNR) is a humane approach for feral cats.

The size of a colony is dependent on the resources available to the cats. For this reason, removing cats from an area or killing them will not eradicate a colony. As long as resources are available, new cats will move in to take their place. **That is why it is vitally important not to feed feral cats;** if they have an unlimited food supply the colony will stay and grow. Feeding these cats will also attract other undesirable wildlife such as raccoons and skunks.

Ways to Humanely discourage Feral Colonies

We realize that not everyone wants a colony of cats in their backyard. Here are a few helpful and safe tips for discouraging ferals from colonizing your yard, courtesy of Alley Cat Allies.



- Citrus peels and coffee grounds are known cat repellents. Scatter these anywhere you don't want cats hanging out or relieving themselves.
- Keep a tight lid on trash containers, this will also keep dogs and other wildlife out of the trash.
