## **BOND WAIVER FORM**

**BOND WAIVER:** A waiver of the bonding requirement may be granted by the Building Official, upon written application, when, in the opinion of the Building Official, the nature of the particular business activity itself does not pose a danger to the health and safety of the community, or the value of the particular business activity is so small as to pose an insignificant risk to the health and safety of the community. When a waiver is granted for any construction activity, each subsequent building permit applied for will require approval of an additional written application for a waiver of bonding requirement or the submission of an acceptable bond.
