Delaware Solid Waste Authority (DSWA) monitors materials as they are unloaded from trash and recycle haulers, and asks us to keep these items **OUT** of your Recycling Cart. Styrofoam * Motor Oil Containers * Chemical Containers * Ceramics &



Understanding your City of New Castle Property Tax Bill

Please note: the City does not accept a postmark to qualify payment as on time. Payment

must be received in our office either by mail or in person by the close of business on the due date.

The City offers a 2% discount if payment is received at the City office by 4:30 p.m. on Aug. 31st.

From September 1st through September 30th the base tax amount is due. Payment must be received at the City office by 4:30 p.m. on Monday, October 1st or a 6% late penalty will be applied, with an additional 1.5% per month accrued on all unpaid taxes.

For your convenience the City has 3 ways to pay:

- Pay by mail, using envelope included with your bill. (Please note, postmark not accepted)
- * Pay in Person at our office: 220 Delaware Street (Cash, Check or Money Order Only)
