In 2019, the Municipal Services Commission (MSC) of the City of New Castle began offering the ability to pay bills on the telephone (in addition to online). Customers are able to call 1-866-236-8299 and make a payment or just check their balances. The system is completely Interactive Voice Response (IVR) and user-friendly. If you do have problems with utilizing the service please feel free to contact the MSC's customer service at 302-323-2330 and they will be able to assist you.

We would like to caution ALL MSC customers as we are aware of scammers calling customers and advising their service will be discontinued if they do not call an 800 number to make payment. Please think TWICE before making payments over the phone and be sure you are calling the correct numbers.

One of many benefits of Public Power is that we are local and if you are unsure about a phone call you can just stop in our office and we can assist you with your payments.

The MSC does utilize Tyler Notify (electronic phone calls) to remind customers their payments are due, however, customers will typically receive one call per month. We will not call you over and over again as many scammers are known to do. Again, please call our Customer Service or stop by our office if you have any questions 302-323-2330.

Don't miss the February 3rd deadline to renew your City Business & **Rental Housing Licenses**

All businesses located in and/or working within the city limits of New Castle, must have a 2020 New Castle City business license.

All rental properties must renew their New Castle City Rental Housing Business License annually. Both license applications are available at the City Administration Building, 220 Delaware Street or on the City website at newcastlecity.delaware.gov.

Business Licenses for businesses located within the City Limits and Rental Business Licenses are due by February 1st, after which a late fee will be assessed at 10% per month. Applications can now be submitted online on the City website's forms-and-fees page. Call 302-322-9801 with any questions.

§ 94-1 Defecation on public or private property prohibited; owner to remove feces. It shall be unlawful for any person to PICK IT UP knowingly permit a dog, cat or other domestic animal owned or subject to the control of such

person to defecate upon any street, sidewalk or park, or upon any public property, or upon any private property within the City of New Castle without the consent of the owner or tenant of such private property. In the event that any dog, cat or other domestic animal deposits its excrement upon any public or private land within the City of New Castle, such owner of said dog, cat, or other domestic animal shall remove immediately, in a sanitary manner any fecal matter deposited by said dog, cat or other domestic animal.
