# **Understanding your City of New Castle Property Tax Bill**



Please note: the City does not accept a postmark to qualify payment as on time. Payment must be

received in our office either by mail or in person by the close of business on the due date.

The City offers a 2% discount if payment is received at the City office by 4:30 p.m. on August31st.

From September 1st through September 30th the base tax amount is due. Payment must be received at the City office by 4:30 p.m. on September 30th or a 6% late penalty will be applied, with an additional 1.5% per month accrued on all unpaid taxes.

## For your convenience the City has 4 ways to pay:

- \* Pay by mail, using envelope included with your bill.
- \* Pay on the City's website: www.newcastlecity.delaware.gov.
- \* Check and money order payments are accepted at the New Castle Administration Building, located at 220 Delaware Street, New Castle. A drop box is available for making check and money order payments 24 hours a day in the front door entrance of the New Castle Administration Building.
- \* Cash and in person payments are accepted by appointment only. Please call (302) 322-9804 to make an appointment between the hours of 8:30 a.m. and 4:30 p.m., Monday through Friday.

### **BOARD OF TRUSTEES OF THE NEW CASTLE COMMON**

The Trustee election that was originally scheduled for March 21, 2020, and suspended due to the Corona virus, will resume according to the following schedule. This election is necessary to

fill the seat formerly held by Beverly Ross.

**DATE:** August 29, 2020

**PLACE: GOODWILL FIRE STATION** 

TIME: 8 AM UNTIL 4 PM

Precautions will be taken in light of the Corona virus. Two persons at a time will be allowed in the polling place. Hand sanitizer will be available. Voting machines will be wiped with sanitizer after each use. Bring proper identification showing your current address.

Additionally, beginning on August 12, 2020, and ending on August 28, 2020 at 2 p.m., early voting will be available in the Trustees' office at 201 Delaware Street. Normal business hours are from 10 a.m. until 3 p.m., Monday through Thursday. The office will also be open for voting on Friday, August 28, 2020, from 10 a.m. until 2 p.m. Voters need to be registered on the Trustees' Voter List, and must have proper identification.

Precautions will be taken in light of the corona virus. A mask must be worn, covering your mouth and nose, to enter the office. One voter at a time will be allowed into the office. A distance of at least six feet will be required between all persons in the office. Hand sanitizer will be available.

Absentee ballots will be available by mail. Call (302) 322-2809 to request that a ballot package be mailed to you. Requests will be taken starting on August 1, 2020, and stopping at end of day on August 17, 2020. Mail in ballots must be returned to the office by 2 p.m. on August 28, 2020.

Votes that were cast prior to the suspension of this election on March 18, 2020, WILL BE COUNTED. If you're not sure whether you already voted in this election, you can inquire at 302-322-2809.
