#### WATER RATES TO BE INCREASED

Municipal Services Commission's rate design consultant, Utility Financial Solutions (UFS), recommended a 9% overall water revenue increase after reviewing the cost of service study. UFS also recommended reducing electric rates, which the MSC approved in May 2020. The electric rate reduction was a result of lower power supply costs. The water rate increase will result in an average residential customer experiencing an increase in their monthly bill of approximately \$4.00.

MSC is sensitive to customers experiencing additional financial burden during this national crisis (COVID-19 pandemic), which is why MSC delayed this rate increase from the recommended effective date of April 2020 to October 2020. ### **Code Enforcement Corner**

Garbage, Yard Waste & Recycle § 204-6 Rules and regulations governing disposition and collection of garbage, and refuse.

Place trash, yard waste and recycle at the curb the <u>night</u> <u>before your scheduled pick-up day</u>. Public Works crews start pick up at 7 a.m. in the fall and winter.

**TRASH:** All garbage is to be secured in plastic bags and placed inside solid containers with lids, each residence may place up to four (4) 35 gallon/50 pounds maximum at the curb for pick-up. All containers must be removed from the sidewalk or roadway and stored on the <u>same day</u> that they are picked up. Containers shall be placed or stored in the rear of residence, or along the side yards or alleyways but not within five feet of the front of the dwelling unless concealed by a fence.

**YARD WASTE & LEAF PICK-UP:** Yard waste including branches, tree trimmings, sticks, grass clippings are collected on Wednesdays. Such refuse may be placed

- Never dump anything down a storm drain.
- Keep grass clippings off of sidewalks and streets.
- Use fertilizers and pesticides sparingly and sweep up any excess.
- Check your car for leaks, and recycle used motor oil.
- Take your car to a car wash, instead of washing it in your driveway.



- Pick up after your pet.
- Compost your yard waste.

unbagged into a container or paper bag or securely tied together in bundles, each of which shall not exceed 50 pounds in weight or four feet in length. Grass clippings, leaves and other garden refuse may be bagged (paper) not to exceed 50 pounds in weight. Once leaf pick-up starts, rake leaves to the curb for pick-up. Rake ONLY leaves to the curb, no sticks or other debris may be in leaf piles, as that may damage the machinery.
