## TRUSTEES SCHOLARSHIP FUND APPLICATIONS

### The Scholarship Application for the 2022-2023 Academic School Year will be Available in Late February

The "Trustees of New Castle Common Scholarship Fund" was established in 1983 for eligible residents of the City of New Castle.

The scholarships are awarded to full-time residents of the City of New Castle and are for undergraduate study only. High school seniors must provide an acceptance letter from a college or university to be considered for the Scholarship. If the applicant is a dependent, the parent must be a resident of the City of New Castle.

An applicant must be a senior in high school or a high school graduate who is entering an accredited undergraduate college or university as a full-time student in the coming semester.

## MSC to Partner with William Penn High School in Pre-Apprenticeship Program

Municipal Services Commission has partnered with the Delaware Rural Water Association to assist with William Penn High School's Water Management Pre-Apprenticeship Program. Students will attend 34 after school classes from January-May. Water Supervisor Ryan Jaeger and Water Manager Jay Guyer will provide Hands-on activities to enforce the knowledge learned in class. Activities include visiting MSC's Water Facilities to learn how a water system operates, learning how to perform chemical tests on the water and how to properly collect water samples for analysis.

Classes also include learning about GIS Mapping, how plans are developed and read, and knowledge on MSC's computer SCADA system and how it helps control and monitor MSC's water system. This partnership will assist in providing students with potential job shadowing and they can continue their education in DRWA's Registered Water Operator Apprenticeship Program to become a Licensed Water Operator.

## Code Enforcement Corner



**REMINDER:** It is the responsibility of property owners to maintain the sidewalk in front of their property within 24 hours of the end of a weather event.

**The New Castle City Code, section 209-1:** Sidewalks require a minimum 3 feet of clearance within 24 hours of a snow event ending.

renew your City Business &  
Rental Housing Licenses**

All businesses located in and/or working within the city limits of New Castle, must have a 2022 New Castle City business license.

All rental properties must renew their New Castle City Rental Housing Business License annually.

Both license applications are available at the City Administration Building, 220 Delaware Street or on the City website at [newcastlecity.delaware.gov](http://newcastlecity.delaware.gov).

Business Licenses for businesses located within the City Limits and Rental Business Licenses are due by February 1st, after which a late fee will be assessed at 10% per month.
