New Castle City Code, § 209-1. Removal of Snow and Ice Required.

The owner, tenant or occupant of any property, shall remove any snow or ice from sidewalk or footway along and adjoining property within 24

hours the end of a weather event. Said owner, tenant or occupant shall cause a pathway to be cleared at least three feet in width along the pavement or sidewalk to the gutter to allow the free passage of pedestrians.

If off-street parking is available, please move vehicles, if possible, to facilitate plowing.

A Reminder from Good Will Fire Company

If you have a hydrant near your property, please help clear the area around it in the event of snow. This could save crucial minutes in an emergency. In case of fire, our firefighters need to be able to get to the hydrants quickly to protect people and property.





Trustee Community Grant Program

The Trustees of the New Castle Common have posted the 2023-2024 Grant Application on their Website:

www.trusteesncc.org.

Organizations within the town of New Castle can apply for grants. The Trustees mission is to manage its resources "for the benefit of the citizens of New Castle." Citizens are defined as the residents of the incorporated area of the City.

If an organization has activities both inside and outside of the New Castle City limits, the Trustees can only support those activities within the City. Information and documentation provided must clearly indicate the location of services provided.

Remember! Your organization must complete and return the "Grant Request Application" to the Trustees of the New Castle Common by December 31, 2022.

Trustees Scholarship Fund Applications and Mid-Year Renewals

The "Trustees of New Castle Common Scholarship Fund" was established in 1983 for eligible residents of the City of New Castle.

The scholarships are awarded to full-time residents of the City of New Castle and are for undergraduate study only. High school seniors must provide an acceptance letter from a college or university to be considered for the Scholarship. If the applicant is a dependent, the parent must be a resident of the City of New Castle.

An applicant must be a senior in high school or a high school graduate who is entering an accredited undergraduate college or university as a full-time student in the coming semester.

Funded applicants from the Fall semester need only send in an official **Fall 2022** grade transcript prior to the **January 2, 2023** deadline.

Please call 302-322-2809 with any questions about the process or about residency in the City of New Castle. Please note the application and/or all necessary information must be received by the Scholarship Committee no later than **Ianuary 2, 2023**.
