Trustees Scholarship Fund Applications for 2023/2024 School Year are Available Now

The "Trustees of New Castle Common Scholarship Fund" was established in 1983 for eligible residents of the City of New Castle.

The scholarships are awarded to full-time residents of the City of New Castle and are for undergraduate study only. High school seniors must provide an acceptance letter from a college or university to be considered for the Scholarship. If the applicant is a dependent, the parent must be a resident of the City of New Castle.

A new applicant must be a senior in high school or a high school graduate who is entering an accredited undergraduate college or university as a full-time student in the coming Fall semester. The application deadline is **July 5**, **2023**.

Applicants from the 2022/2023 school year must complete another application at this time and provide an official Spring 2023 grade transcript prior to the **July 5, 2023** deadline.

Completed applications can also be hand delivered to the same address Monday – Thursday, 10 a.m. until 3:30 p.m.

New Air Conditioner Rebates Available for New Castle Electric Customers

Efficiency Smart has introduced a \$100 rebate on qualifying central air conditioners and a \$50 rebate on qualifying window air conditioners for Municipal Services Commission of the City of New Castle electric customers.

Energy-efficient air conditioners can help keep homes cool while reducing energy use compared to standard models. This makes upgrading to an efficient model a smart choice for those looking to replace their aging air conditioner ahead of the cooling season.

Qualifying central air conditioners use eight percent less energy than standard new models while qualifying window units use nine percent less energy than standard models.

To celebrate the launch of the new rebates, Efficiency Smart is giving away a window air conditioner on its Facebook page. New Castle customers can visit www.Facebook.com/EfficiencySmart between March 1st and March 8th to learn more and to enter the contest.

Only qualifying air conditioner models purchased after February 28, 2023, are eligible for Efficiency Smart's rebates.

Recycling Information at your Fingertips

Recyclopedia, administered by the DNREC Division of Waste and Hazardous Substances, helps users determine the best way to manage waste, whether by recycling or proper disposal. Recyclopedia can be an environmental asset for residents and visitors, whether at home, work, school or while on vacation.

The webpage at <u>de.gov/recyclopedia</u> offers an easy-to-navigate, pictorial guide for more than 375 common items – providing an instant response on how and where these items can be most efficiently recycled or disposed of, and directing app users to the nearest locations for either consumer action. Recyclopedia information can be retrieved by PC, tablet, cell phone, or other devices.

Curbside single stream recycling is easy if you follow these simple steps!

- **Don't Use A Bag!** Never bag recyclables. Items should be placed in the recycle cart loose.
- Empty. Clean. Dry.

All items that you place in your recycling cart need to be emptied of their contents, cleaned of residue, and free of moisture.

What <u>cannot</u> go into recycle carts: No Plastic bags, food waste, electronics or batteries. No yard waste, Styrofoam, window glass, mirrors, scrap metal or shredded paper. No frozen food containers, and no "tanglers." Items like hoses, string lights and wires tangle up recycling equipment.
